- 4. Applications which are illegible or do not conform to general instructions & Annexure 'A' are liable to be rejected.
- 5. Incomplete applications shall be summarily rejected.

- 16. The engagement will be purely on contract basis initially for one year.
- 17. For one year contract, extension will be yearly basis while for 03 years contract extension will be of 02 years on basis of satisfactory performance.
