In addition to Basic Pay, other allowances & facilities like Central Dearness Allowance, Children Education Assistance, Canteen Subsidy, Site Allowance, Cable TV reimbursement, News Paper Reimbursement, Medical Assistance, Site Conveyance Allowance, Washing Allowance, Accommodation, School facility etc. will also be admissible from time to time as per Corporation Rules.

Note - 1:

- Relaxation in upper age limit will be allowed in the case of candidates with longer experience and outstanding merit
- Upper age limit is relaxable by 3 years for OBC.
- The relaxation of age for Ex-Servicemen shall be as per the Government directives.
- Additional relaxation in prescribed age limit commensurate with experience of working with NPCIL on Contract/Fixed Term Basis, subject to a maximum of 5 years will be given.

2. Eligibility Criteria:-:-

01.	Educational Qualification	SSC or equivalent with valid Heavy Vehicle Driving License. (Persons having Certificate Course from State Fire Training Centers or having knowledge of fire fighting equipment such as Fire Extinguishers etc will be given preference). Knowledge of English is desirable.
02	No. of years of relevant experience after obtaining requisite qualification	3 years experience in driving heavy vehicle after obtaining requisite qualification. (Experience in a Fire Service Organization/ Defense Service will be preferred)

Note -3

- (i) Candidates must have already passed the qualifying examination as on the last date of receipt of application. Candidates who have appeared for the qualifying examination but whose results are not declared by the crucial last date for submitting the application, are not eligible.
- (ii) Qualification should be full time regular course.

4. Physical Endurance Test (P.E.T.)

Candidates should qualify in physical endurance test viz running 100 meters with 64 kgs. weight in one minute, climbing of rope and/or vertical pipe to a height of at least three meters from the ground. Candidates should also qualify in the driving test.

Application should be accompanied with self attested copies of certificates in support of educational qualifications (SSC onwards for all the semesters/years with mark sheet), date of birth certificate, Heavy Vehicle Driving Licence, Discharge certificate in case of Ex-Servicemen, Experience certificate and OBC (Non-creamy layer prescribed for appointment to posts under Government of India issued during the year 2015-16) from the appropriate authority in the prescribed format wherever applicable.
4. Applicant should affix a passport size photograph duly signed with date and place at the space provided in the application format.
5. The application and outer cover should be super scribed with "**APPLICATION FOR THE POST OF Driver-cum-Pump Operator-cum-Fireman/A**"
6. Applicants should ensure that all the columns of the application form are duly filled or struck out which are not applicable.
7. The OBC applicants who belong to "CREAMY LAYER" are not entitled for OBC concession and such applicants have to indicate their category as "General".

9. Applicants shall indicate their physical standard i.e. Height, Weight, Chest size, vision in the appropriate column of the application form. The applications in which these columns are not filled will be rejected as incomplete application.

They may however, send one advance copy of the application indicating on top left side of application as "Advance Copy" along with self-attested enclosures as detailed above.

The recruitment process will consist of Written Test, Physical standard verification, Physical Endurance & Driving Test in that order and /or as prescribed by the Corporation for recruitment of these posts from time to time.
