2) Application Fees

- a. Rs.500/- (Rupees Five Hundred only) though bank challan which is available in the university website. You will have to download the challan, fill the same and deposit the fees to nearest branch of State Bank of India then send the University Copy of the Challan along with the Application Form.
- b. SC/ST and PH candidates need not pay any fee for application.

3) Documents to be submitted alongwith application:
