1. Pre-requisites & other Conditions:

Qualification: Degree in Law of Recognized University.

Experience:

- i) **Chief Legal Advisor-** Minimum 7 (Seven) years' experience in a position of District Judge.
- ii) **Legal Advisor -** Minimum 3 (Three) years' experience in a position of District Judge.

Upper age limit : 65 years for post of Chief Legal Advisor and 63 years for the post of Legal Advisor. The upper age limit is relaxable in case of deserving candidates, if found fit.
