The final selection of Junior Residents (Dental) shall be done on the basis of **written test** to be held on **22/05/2017**.

For Senior Residents in Dental Department written test, if needed, shall be held on **24/05/2017** followed by interview of shortlisted candidates on **26/05/2017 at 10.00 am** (List of short listed candidates for interview shall be displayed on or before **4.00 pm** of **25/05/2017**).

GENERAL TERMS AND CONDITIONS

1. **3% seats shall be reserved for physically handicapped persons as per rules.**
2. Number of the vacancies is provisional and subject to change without any notice.
3. These include vacancies likely to fall vacant up to 31.05.17.
4. Selected candidates may be posted under any institution under RDHS (North), if felt necessary in public interest.
5. Panel of wait listed candidates will be prepared for filling the post of SR/JR for vacancies arising in future. The panel shall remain valid for 6 months or till fresh selection process is carried out, whichever is early.
6. In case, SC/ST/OBC candidates are not available for SR and JR, the post shall be filled for 89 days on adhoc basis from General Category Candidates and vice versa.
7. In case interview for all candidates is not completed on the scheduled date/duration, the interview shall be continued on following working day.
8. In case scheduled date happens to be holiday for any reason, the scheduled activities shall be carried out on next working day.
9. No TA/DA will be paid for participation in selection process.
10. The appointment and services will be governed under Residency Scheme.
11. All appointment shall be subject to medical fitness and verification of certificate of educational qualification /age/caste/submission of valid DMC registration certificate and internship completion certificate etc.
12. Medical Director being HOD of the institution shall reserve rights to make just changes in the schedule / selection process in public interest.
13. The decision of the Medical Director shall be final under all circumstances.

SPECIFIC TERMS AND ELIGIBILITY CONDITIONS AS APPLICABLE TO VARIOUS POSTS

1. TERMS & ELIGIBILITY FOR THE POST OF SENIOR RESIDENTS:-

- I. **Qualification** : MBBS with Post graduate degree/DNB/Diploma or equivalent as per Residency Scheme in concerned specialty from a recognized university/Institute. Must **not** have completed 03 years Senior Residency in any recognized institute including regular or adhoc basis. In Superspeciality branches preference shall be given to candidates having Superspeciality qualification or experience.
- II. **Age As On 30/04/2017**: Shall be maximum of 33 years for PG Degree and Diploma holder and 35 years for post Doctoral Degree holder as per Residency Scheme, as on 30/04/2017. The age is relaxable up to 05 years for SC& ST and 3 years for OBC candidates (OBC candidates belonging to Delhi only). In case of non availability of the candidates age can be relaxed under relaxed category in accordance with circular no F121(26)/2010/H&FW/DSHFW/1996-2045 dated 10.06.2011 issued by H&FW Department, GNCTD.
- III. **Pay Scale** : Shall be in accordance with 7th CPC guidelines as adopted by GNCT of Delhi.
- IV. The candidate must have valid Registration with Delhi Medical Council or must have acknowledgment of having applied for the same.
- V. Appointment will be initially for period of one year and will be extended further on yearly basis upto maximum of 03 years on the basis of satisfactory Work & Conduct report from concerned HOD and a written request from the Doctor concerned.

- VI. In the specialities where there is perpetual shortage like radiology, anesthesia etc or in specialties where no fresh candidates are available, candidates who have completed 03 years Senior Residency but are willing to serve as Senior Residents may also be allowed to appear in the interview.
 - a) Separate merit lists for fresh candidates and for others (those who have completed 03 years of residency) would be prepared.
 - b) Firstly, the list containing names of fresh candidates would be exhausted for appointment as senior residents and the second list would be used only after that.
 - c) Further, all Senior Residents appointment from second list will be for one year only. It would not be renewable after one year.

2. TERMS & ELIGIBILITY FOR THE POST OF JUNIOR RESIDENTS (MBBS):-

- I. **Qualification:** MBBS or equivalent degree from a MCI recognized university / Institute. Foreign Graduates must have cleared FMG examination. The candidate must NOT have done Junior Residency of One year from any recognized institute.
- II. **Age As On 30/04/2017:** Age limit is 30 years for junior resident as on 30/04/2017 and will be relaxed for SC/ST/OBC candidates (OBC candidates belonging to Delhi only) as per rule. Enabling provisions of circular no F121(26)/2010/H&FW/DSHFW/1996-2045 dated 10.06.2011 issued by H&FW department, GNCTD shall be applicable if needed.
- III. **Pay Scale :** Shall be in accordance with 7th CPC guidelines as adopted by GNCT of Delhi.
- IV. **Internship :** must have completed one year rotatory internship on or after 30.04.2015.
- V. The candidate must have valid Registration with Delhi Medical Council or must have acknowledgment of having applied for the same.
- VI. Appointment will be initially for a period of six months extendable up to maximum of one year on the basis of satisfactory Work & Conduct report from the concerned HOD and written request from the Doctor concerned.
- VII. Candidate must have not completed one year's Junior Residency from any recognized Institution.
 - a) Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the interview and will be offered residency only if fresh Junior Residents are not available. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provision.
 - b) Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as Junior Residents if no fresh graduates are available.

3. TERMS & ELIGIBILITY FOR THE POST OF SENIOR RESIDENTS (Dental):-

- I. **It is clarified that Posts of Senior Resident are in GENERAL DENTISTRY. The Senior Resident shall have to perform duties under General Dentistry and manage emergency and indoor cases also.**
- II. **Qualification:** MDS degree in any specialty from recognized university / Institute. Must **not** have completed 03 years Senior Residency in any recognized institute including regular or adhoc basis.
- III. **Age As On 30/04/2017:** Shall be maximum of 33 years for PG Degree and Diploma holder and 35 years for post Doctoral Degree holder as per Residency Scheme, as on closing date of submission of application. The age is relaxable up to 05 years for SC& ST and 3 years for OBC candidates (OBC candidates belonging to Delhi only). In case of non availability of the candidates age can be relaxed under relaxed category in accordance with circular no

F121(26)/2010/H&FW/DSHFW/1996-2045 dated 10.06.2011 issued by H&FW Department, GNCTD.

- IV. **Pay Scale:** Shall be in accordance with 7th CPC guidelines as adopted by GNCT of Delhi.
- V. The candidate must have valid Registration with Dental Council of Delhi or must have acknowledgment of having applied for the same.
- VI. Appointment will be initially for period of one year and will be extended further on yearly basis upto maximum of 03 years on the basis of satisfactory Work & Conduct report from concerned HOD and a written request from the Doctor concerned.

4. TERMS & ELIGIBILITY FOR THE POST OF JUNIOR RESIDENTS (Dental):

- I. **Qualification** : BDS degree from recognized university / Institute. The candidate must NOT have done Junior Residency of six months or more from any recognized institute.
- II. Age limit is 30 years for Junior Resident as on 30/04/2017 and will be relaxed for SC/ST/OBC candidates as per rule.
- III. **Pay Scale:** Shall be in accordance with 7th CPC guidelines as adopted by GNCT of Delhi.
- IV. The candidate must have valid Registration with Dental Council of Delhi or must have acknowledgment of having applied for the same.
- V. **Internship** : must have completed one year internship on or after 30.04.2015.
- VI. Appointment will be initially for a period of six months extendable up to maximum of one year on the basis of satisfactory Work & Conduct report from the concerned HOD and written request from the Doctor concerned.

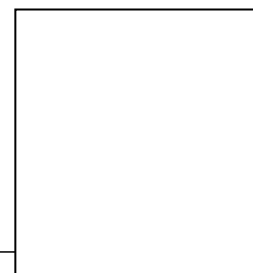
